Special Rules due to Covid 19

Basics: Verordnung der Landesregierung Baden-Württemberg über infektionsschützende Maßnahmen gegen die Ausbreitung des Virus SARS-CoV-2 vom 23.06.2020 in der ab 06.08.2020 gültigen Fassung

Verordnung des Kultusministeriums und des Sozialministeriums Baden-Württembergs über die Sportausübung (Corona-Verordnung Sport – CoronaVO Sport) vom 3. September 2020

The following rules of conduct must be strictly observed. The Team Captain is responsible that the team members are informed about the rules and follow the rules.

- Spectators are not allowed. The access routes to the competition area will be closed for the public. (see also the attached map)
- People who had contact to a person which is/was infected with Corona in the last 14 days or people who have the typical symptoms of a Corona infection like odor/taste disorder, fever, cough, or sore throat are not allowed to enter the Adler Skistadium and to participate.
- Officials, coaches and athletes which are arriving from area which is a risk region according to the Robert-Koch-Institut

- In order to enable a contact person identification in the event of a subsequently identified COVID-19 case, the phone numbers and e-mail addresses of the respective trainers are recorded. The athletes can then be assigned to the coaches on the basis of the starting lists. The data of the present officials are also recorded. The data will be deleted permanently after four weeks.
- All people at the venue have to observe the minimum distance of 1,5 m between each person. If it is not possible to keep the minimum distance it is obligatory to wear a mask.
- The stay at the basement building has to be reduced to a minimum. At the building it is necessary to wear a mask. For extern people the entry to the basement building is forbidden.
- The team area is located at the end of the outrun at the K 70 (see map). The Nations will get cabins for changing the clothes. After the competitions the cabins have to be emptied and must be ventilated. Each nation get an separat space before their cabins where only the team members are allowed to stay there.

- The toilets are in the basement building and will have an separate entry and exit. Pay attention to the desinfection of your hands after using the toilets.
- The pick up of the bibs will be outside a cabine near the basement building per nation.
- For transportation to the start area the lift will be used. There are only two person per row allowed. The place in the middle has to be leave free. At the waiting area and at the entry and exit the minimum distance must be kept. Before entering the bottom station the hands must be desinfected. If with have to use the shuttle bus it is obligatory to wear a mask at the bus.
- There will be a stand where food and drinks will be sold. The food can be eaten outside in the area. Eating in the cabins is not allowed.
- In the judges tower it is obligatory to wear a mask. The only exception is at the working spaces where the minimum distance can be kept.
- At the coaches stand it is also obligatory to wear a mask.
- Only one coach per nation is allowed at the start- and finish area of the race. Except the athletes all people in this areas have to wear a mask.
- Start and result lists will be published at https://www.deutscherskiverband.de/leistungssport_skisprung_ergebnisse_neu_de,384.html and https://www.deutscherskiverband.de/leistungssport_nordische-kombination_ergebnisse_neu_de,396.html. There will be no distribution at the race office to minimize the persons which will visit the race office.
- At the price giving ceremony it is obligatory to wear a mask.
- Persons who will break this rules will be removed from the area and are not allowed to come back during the whole weekend.

Liability

1. Risk assessment and personal responsibility of the participants:

In the DSV-active declaration for the receipt of their starting pass, the participants have stated in detail that they are aware of the competition-specific risks and dangers and that they accept them. To be further informed that in this respect you may suffer damage to life or limb while exercising your chosen ski discipline. After all, they have undertaken to carry out their own risk assessment to determine whether, based on their individual skills, they are confident enough to cope with the difficulties of the route or facility and are also obliged to point out any safety deficiencies they have recognized. With their start they express on the one hand the suitability of the route and on the other hand they are able to meet the demands of the route. In addition, they have expressly confirmed in the active declaration that they are responsible for the material they use. These declarations are also binding for this competition.

2. Fault of the organizer and his vicarious agents:

The participant in the competition accepts, if he suffers damage in the competition and is of the opinion that the responsible organizer or his vicarious agents are at fault for this, that they are only liable for damage to property in the case of intent or gross negligence. This declaration applies also for the legal successor of the athlete. The participant further declares that he is ready to familiarize himself with the respective competition regulations. If a third party suffers damage through his participation in the competition, he accepts that he alone can bear any liability. It is therefore in your own interest to have sufficient insurance coverage.

General Data Protection Regulation: Data protection declaration for sporting events / competitions

1. We, the Ski Club Hinterzarten, represented by the 1st board, are responsible for processing your personal data. Please address all your requests, suggestions and questions to: info@skiclub-hinterzarten.de or the o. g. Address.

2. When registering for the above Sporting event, we collect the following categories of data or the following personal data from you: personal master data (first name, last name, year of birth, if applicable nationality, club membership) and contact details (Telephone number, email address) from you directly or from your regional association when you register through them or are reported to us by them.

3. Your data will be processed in order to fulfill the sports event contract to which you are a party. To do this, it is necessary to identify you in order to check the payment of the entry fee, your entry authorization and the existence of insurance coverage and, if necessary, to contact you for any queries, assign you a start number, the admission, the competition, the accompanying program, the accommodation and / or to organize and carry out catering and other event-related services. Only your personal master data (first and last name, year of birth) and your club membership are published for the publication of lists of results and award ceremonies.
