# **Liability:**

- 1. Risk assessment and personal responsibility of the participants:
  In the DSV Active Declaration for obtaining their Start Pass, the participants have declared in detail that they are aware of the risks and dangers and accept them. Furthermore to be informed that they, insofar as to the extent that they may suffer harm to life or limb in the exercise of their chosen ski discipline. Finally, they have undertaken to carry out their own risk assessment to determine whether, on the basis of their individual skills, they are able to cope with the the difficulties of the course or facility safely, and they must also and are also obliged to point out any safety deficiencies they have identified. By their the suitability of the course and to be able to cope with its requirements. In addition, they have declaration that they are responsible for the material they use. These declarations are also binding for this competition.
- 2. Fault of the organiser and his assistants:

The participant in the competition accepts, if he/she suffers damage in the competition and is of the opinion that the organiser responsible or his vicarious agents are at fault. The organiser or his agents are at fault, that they shall only be liable for damage to damage to property only in the case of intent or gross negligence. This declaration shall also apply to the legal successor of the athlete. The participant further declares that he/she to familiarise himself with the respective competition regulations. If a third party suffers damage as a result of his participation in the competition, he accepts, that any liability may be borne solely by him/her. It is therefore in his own interest to have sufficient insurance cover.

## **General Data Protection Regulation:**

For this purpose, it is necessary to identify you in order to check the payment of the entry fee, your eligibility to start and the existence of insurance cover and, if necessary, to contact you for queries, to allocate you a start number, to organise and carry out the entry, the competition, the accompanying programme, accommodation and/or catering and other event-related services. Only your personal data (first and last name, year of birth) and your club affiliation will be published for the purpose of publishing lists of results and award ceremonies.
